We also decided, as I mentioned, that before we emigrated to Kilimanjaro we would make a thorough study of Kirinyaga's history so we could avoid all of the mistakes that they had

made. Understanding and pinpointing those mistakes is part of my job. I am David ole Saitoti, which means

“David, son of Saitoti”, and I am, by profession, an historian. I was one of a half dozen assigned to study all aspects of Kirinyaga, and since I’m the only one who chose to emigrate to Kilimanjaro, I have been entrusted with the task of recording Kilimanjaro’s history.

Merely inhabiting an empty world is a monumental chore. Turning that world into a Maasai Utopia is an even greater one. I do not expect to be able to write a daily diary, but I will codify the more important episodes in our early history as time allows.

I don’t yet know exactly what shape

our Utopia will take, but with all the examples we have to learn from, and especially from Kirinyaga, I know this much:

This time we will do it right.

Sunrise on Kilimanjaro (2234 a.d.)

The Kikuyu were slaves to their tradition, and this was a mistake we were determined to avoid. One size doesn't fit all, and neither does one way of life.

The Maasai were among the last people on Earth to break with tradition, and for those who still chose to live the traditional pastoral lifestyle, we arranged for fully half of Kilimanjaro to be open grazing land. Before the coming

of the Europeans, almost every African tribe used cattle as currency. A bride would cost so many cattle, a chief would penalize a wrongdoer so many cattle, and so on. For the Maasai the cattle were even more important, for most of us, and especially our elmoran—our young warriors—lived on a mixture of the blood and milk. When our religious ceremonies required it we would sacrifice a steer or a cow and cook and eat it, but their primary purpose was to serve as currency and to provide blood and milk.

The Westernized Maasai cast aside their red blankets and began wearing slacks, shirts, dresses, and suits. They rid their heads of their red ocher paints,

they traded their cattle for cash and their spears for briefcases. And yet they were Maasai too, and had to be accommodated. So we had manyattas for the traditionalists, and cities for the rest of us. There were some farms as well, for while many Maasai chose to exist solely on the milk, blood and meat of their cattle, others had grown used to a Western diet.

There are five cities on our world. I have read much speculation concerning that number: some feel five is a mystic number to the Maasai, some say we had wanted to build more cities but were denied funding, and I have even read one so-called scholar who opined that we could count no higher than the five

fingers on our hand. (Evidently he never realized that Maasai are born with two hands—or perhaps he had only one, and assumed that everyone else did also.)

Anyway, the truth is much simpler than the speculations: the Maasai are comprised of five clans—the ilmakesen, il-laiser, il-molelian, il-taarrosero, and il-ikumai, and we built a city for each of them, though of course no one is restricted to the city of his clan.

Immigration is encouraged, for we have a world to fill. Each potential new citizen is given an orientation course, for we don't want anyone deciding once they arrive that this is not the Utopia they had hoped for. Part of that indoctrination is a holo of all aspects of life on

Kilimanjaro, those that exist and those that are anticipated, so there will be no surprises. Another part is a documentary holo—a re-creation, actually, since nothing Western was allowed there, including cameras—of the first two decades of Kirinyaga's history, so they can see how the best of intentions can go wrong, and hopefully understand that when certain laws and rules are made and enforced it isn't done in an idealistic vacuum, but because we have learned from others' mistakes.

We are so sure that Kilimanjaro will prove to be the one world that actually fulfills its Utopian promise, that we have decided we need a policy to determine who will receive favored status for

immigration once we have filled our empty plains and cities. In fact, this is the first major decision the Council of Elders will have to make.

The Eutopian Council, which gave us our charter, gently hinted that they would like to see a democracy develop on Kilimanjaro, and perhaps someday it will, but only if it evolves out of the Maasai tradition, and that tradition is to bring all disputes to the elders of the tribe. Local problems are dealt with by local Councils, but since the problem of immigration concerns the entire world, in this case the Council is composed of one Elder from each of the five cities, and two from the land of the manyattas. The first question was: who may

immigrate to Kilimanjaro once we have reached fifty percent of our capacity?

The answer was simple: this is a Maasai world, so at that point only Maasai may immigrate. The next question was more difficult: who is a Maasai?

Those who had always tended their cattle and lived in their huts on their manyattas are traditional Maasai, but these days, in the 23rd century of the Christian era, they comprise no more than twenty percent of our population. Most of the Maasai have moved to the great cities such as Nairobi and Dar Es Salaam, Naivasha and Dodoma, and have interbred—is that the right word? It is the most accurate, though I think the

Council prefers “intermarried”—with members of other races: the Kikuyu, the Luo, the Nandi, the Zanake, and more.

The Council debated this for four days, and decided that anyone with one-half Maasai blood is a Maasai.

That was when we began to see that no problem is that easily solved in Utopia. Joshua ole Saibull, who had been an attorney back on Earth, and whose mother was Indian, argued that this was a distinction that would disenfranchise future generations. When asked how, this is what he replied:

“I myself am half Maasai. My wife’s father was a Rendille, and her mother a Maasai. So it is clear that we are each half Maasai, and this will also be true of

our children.”

“But,” he continued, “if at any time in the past thousand years any of my forefathers had a child by a woman who was not Maasai—and don’t forget that we used to raid the Kikuyu and other tribes and carry off their women—then a DNA test will show that I am less than half Maasai, possibly forty-nine percent, possibly forty-five percent, but definitely less than half. I am here, my wife is here, and I fully understand that no one is denying us the right to be citizens of Kilimanjaro. But my children and my grandchildren will also test out at less than fifty percent Maasai, and the day may come when Kilimanjaro has more people than it can handle. At that

point will you force my children to leave the planet?”

The Council of Elders replied that of course they would not.

“Even if my children are only forty percent Maasai?” persisted Joshua. Even so, they assured him.

“That is very considerate of you,” said Joshua, as if he were speaking to a jury, and in a way he was.

“Now, what if a potential immigrant is forty-eight percent Maasai? Will you deny him the right to live on a Maasai world, while my forty-percent-Maasai children are allowed to stay?”

The Council of Elders was still considering the ramifications of that argument when another one was

presented to them.

“My name,” said the supplicant, “is Kella Jimo, and prior to coming to Kilimanjaro I lived in Kenya’s Northern Frontier District until a long drought killed my cattle and dried up my wells.” He waited until the sudden whispering and buzzing had stopped. “Yes, I am a Samburu. And yet I claim I have every bit as much right to be here as any of you, for once the Samburu and the Maasai were a single tribe. We both spoke the language of Maa, we both worshipped En-kai, we both shared the same blood. If you take the DNA of any Samburu and trace it back, you will find we are pure Maasai, certainly more so than Joshua ole Saibull or any others

who have lived in the cities of Kenya and Tanzania and intermarried with other tribes. I therefore insist that by your own ruling the Samburu have as much right to Kilimanjaro as the Maasai.”

They are still studying that one, too.

However, while one might view these as time bombs that will explode many decades in the future, they are meaningless right now. We have a world to fill and more immediate problems to confront. One of our most pressing problems is the economy. The city dwellers use cash and credit; the pastoralists use cattle. The Council of Elders must fix the price of a single cow if there is ever to be any commerce

between the two sets of citizens. The pastoralists will not save or invest money; the city dwellers have no place for cattle even if they were willing to keep them. Since we will not force either side to live in a way that is repugnant to them, we have to find a way to accommodate both sides. An historian's job is not only to codify history but to learn from it, and what I have learned is that whatever price the Council of Elders sets, the city dwellers will claim that it is too high and the pastoralists will claim that it is too low.

And yet, when the accusations are over, the Council will set a price, both sides will agree to it since there is no higher authority to appeal to, and that

will be the end of another potential stumbling block on the road to our Utopia.

Then there is the matter of language. When the Samburu said that his people and ours both spoke Maa, he was correct insofar as he went. But more than ninety-five percent of the Maasai speak Swahili, which is the lingua franca among the peoples of East Africa, and ninety percent speak English, which has occasionally been the official language of Kenya and is still the language of business, commerce, and diplomacy.

What language are we to use? If we remain purists and speak only Maa, then no one offworld will understand us. If we speak English, we will be using the

language of our former enemies. And if we use Swahili, we will be using neither our own tongue nor the language of the Eutopian Council and much of Earth itself. It is another problem we had not foreseen, but which we will soon have to solve. My guess is that since all three tongues are known to most of the people we will resolve the problem by ignoring it. If you speak a language that the party you are addressing understands, it makes no difference to the two of you what that language is; and if he does not understand it, common sense dictates that the two of you will experiment with other languages until you come to one you both comprehend. I find this an exciting time. These are merely growing

pains, and I suspect we will have less of them than any of the other Eutopian worlds. One of my functions is to preserve our history, but an equally important one is to help our people learn from the failed histories of the other worlds. One of the things I've learned is that Kirinyaga and many of the other worlds relied too heavily on the assumed wisdom of a single man, such as Koriba. This will not happen on Kilimanjaro. Every citizen has something to offer, and it would be foolhardy of our leaders not to avail themselves of it. For example, the Maasai have produced some of East Africa's finest medical doctors, and some of them have chosen to emigrate to

Kilimanjaro, where each of the five cities has an up-to-date hospital. Kirinyaga's mundumugu may have been expected to cure every illness, but here the patient will see a trained specialist.

We have lived in harmony with Nature for untold centuries, so we created two large game parks, filled with the clones of long-extinct hippos, rhinos, plains game, and just the right ratio of predators so that they neither multiply beyond the parks' ability to feed them or fail to produce enough numbers to replace those who have fallen prey to the lions, leopards and hyenas. The parks are surrounded by a force field so that neither the herbivores nor the predators can ever get out to

annoy or threaten the nearby pastoralists.

Perhaps the most important thing we have done to improve the peoples' lives is the near-total eradication of flies. The huts of the pastoralists are made of cattle dung, and the dung is also spread throughout the manyattas. This attracted myriad flies, which often carried disease. They were omnipresent and annoying, they tended to light on the eyes, and they blinded more than one Maasai child. Our chemists went to work, and now we have a planet without a single fly.

Many have moved here already, and in two more days the last of the cities, the lakes and rivers, the grazing fields, and the manyattas will be complete.

There is even a small church with a steeple out on the pastoralists' lands, for those who have converted to Christianity. Just 48 hours from now our Utopia will be, as the Maintenance crew that built it says, open for business. I can hardly wait.

Morning on Kilimanjaro (2235 a.d.)

We have had so many applicants for citizenship that I've revised my opinion downward: we will be screening potential immigrants for the "purity" of their blood in less than ten years. The cities are already half full. It is more difficult to tell with the manyattas, since all the grazing land is available and the pastoralists have spread their herds out

to cover it. I hope we do not have any problems getting them to share it as more newcomers arrive.

I think that, by and large, our first eight months have gone smoothly. There have been a few disputes over territory, but since we momentarily have an abundance of territory they were quickly settled. There were, as I foresaw, endless complaints about the exchange rate that was finally set for cattle, but eventually both sides accepted the Council's ruling.

One of the unforeseen problems was the value of the shilling itself. It was decided that since shillings were the currency in Kenya and Tanzania, they would also be the currency here on

Kilimanjaro, and this is where we ran into difficulties. The Kenya shilling is worth more than the Tanzania shilling, so when the price of a cow was set at seven hundred shillings, the pastoralists refused to accept Tanzania shillings and insisted they be paid only in Kenya shillings.

It was then decided that a new world required a new currency, and so we created the Kilimanjaro shilling. This presented another problem, for we were inexperienced in such matters. You cannot simply print shillings, or they are worth no more than the paper they are printed on. They must be pegged to something: gold, silver, or some other currency.

We decided to peg ours to the Kenya shilling, since it was the currency with which we were most familiar. Any immigrant could change his Kenya shillings for Kilimanjaro shillings at the posted rate. It seemed simple enough.

But then Kenya went into a recession, and suddenly the Kenya shilling, which was pegged to the British pound, was worth about half what it had been when we had pegged our shilling to it. It was only after some of our city dwellers paid visits to their families back in Kenya, and returned with huge amounts of devalued Kenya shillings, that we had to devalue our currency, and suddenly our own economy was in a deeper recession than Kenya's.

We then announced that the rate of exchange between cattle and shillings would change daily. The pastoralists were certain that this was a way of defrauding them, and the city dwellers objected to the value of our currency depending on the financial actions of the country we had left behind. Eventually this was solved for the simple reason that we could not survive with only a barter economy when the city dwellers had nothing to offer the pastoralists, and the pastoralists had only cattle to offer the city dwellers.

It was painful, and there were some awkward dislocations, but we were fast learners, and even as I write these words the economy is slowly

recovering.

Which is just as well, because other minor problems continue to surface. Some were predictable, and we had prepared for them. Some were completely unforeseen, and required innovative solutions. Like “ole”.

As I mentioned in a previous entry, “ole” means “son of”. Some typical Maasai names are my own David ole Saitoti (David, son of Saitoti), our leading lawyer Joshua ole Saibull (Joshua, son of Saibull), and so on.

Now let me give you the names of my sister, Joshua’s wife, and my neighbor’s wife: Esiankiki, Malaika, and Ledama.

Do you see the difference?

Ledama did, and so she took her

complaint to the Council of Elders.

“Women were treated as second-class citizens for centuries when we still lived in Africa,” she began.

“We did almost all the physical labor, while our men protected the herds from the lions and leopards, even long after there were no longer any lions and leopards to protect them from. It wasn’t until we moved to Nairobi and Mombasa and the other cities that we began asserting ourselves and were finally treated as equals.”

“You are still treated as equals,” said Robert ole Meeli, who spoke for the Council. “What is your complaint?”

“We are not treated as equals,” insisted Ledama.

“In what way?” asked Robert. “No job is closed to you, every job pays the same amount no matter who is working at it, no establishment refuses you entry. So I repeat: what is your complaint?”

“There is an inequity in names,” said Ledama.

Robert looked confused. “An inequity in names?”

“You are Robert son of Meeli,” she said. “I am merely Ledama.”

“Would you rather be known as Ledama ole Koyati?” he asked, and the other Elders chuckled.

“I am not the son of anyone,” said Ledama. “But why can’t I be Ledama daughter of Koyati?”

“It would be a break with a thousand-

year tradition,” explained Robert.

“Then you admit that even after a thousand years you do not think of us as equals,” said Ledama. “Is Kilimanjaro to be a Utopia only for men?”

The Council conferred for less than half an hour, one of its briefer meetings, and declared that from that day forward she could be Ledama daughter of Koyati. And that solved the problem. For twenty-four hours.

Because the next day Ashina, the daughter of Lemasolai, brought her complaint to the Elders.

“Why must I be known as the daughter of Lemasolai?” she demanded.

“Isn’t he your father?” asked Robert ole Meeli.

“Yes.”

“Then it’s settled,” he said.

“It is not settled,” she insisted.

“Didn’t you just reaffirm yesterday that the sexes are equal on Kilimanjaro?”

“Yes,” said Robert, frowning and trying to figure out where this was leading.

“My mother was Kibibi,” continued Ashina. “What makes my father more important than my mother?”

“We have never said that he was,” answered Robert.

“Then my name should Ashina daughter of Kibibi.”

This time it took the Council only ten minutes to agree.

“This subject is now closed,”

pronounced Robert ole Meeli. “If someone shows up tomorrow demanding to be known as the son or daughter of both parents, I will personally take him to the game park and throw him—”

“Or her,” interjected Ashina.

“Or her,” he continued, “to the lions.”

It was an embarrassing two days, even humiliating if you were Robert ole Meeli, but at the end of it women knew beyond any doubt that they were equal citizens of Kilimanjaro. Until the following week, when Ledama stood before the Council of Elders again, demanding to know why no women were on the Council.

This was a greater break with tradition than anything that had gone

The men have been unfair to us for

centuries, argued Ledama. View this as reparation. I am not responsible for what my great-great-great-grandfathers may have done, said Robert, and I will not make reparation for their sins.

Ledama argued, but the Council remained adamant. The next week there were thirteen members of the Council of Elders, seven men and six women.

Mid-Morning on Kilimanjaro (2236 a.d.)

I was sitting in my office, going over some notes I had entered in my computer, when there was a knock at the door. I have no secretary or receptionist,

so I just called out “Come in!”

The door remained closed, so I got up, walked across the office, opened it, and found myself facing a tall thin boy of twelve or thirteen. He was clearly from a pastoralist family, for he wore the traditional red blanket and carried a spear. "Please sit down," I said, walking behind my desk and sitting in my own chair, which hovered a few inches above the ground and changed its shape to firmly encircle me.

"I do not trust chairs that float in the air," he said. "I will sit only on a three-legged stool, such as we have in my parents' manyata."

“Then you shall have to remain standing,” I said. “What is your name?”

“Mawenzi ole Porola,” he replied.

It was very rare to find a Maasai who did not have a Western name, and I must have looked my surprise.

“My father, who named me, did not forget our traditions,” said Mawenzi with a note of pride. “I hope you have not forgotten them either, or my journey here was wasted.” He paused. “It was very hard to find my way among the streets and buildings of the city.”

“Why have you come all this way to see me?” I asked.

“You are the historian, are you not?”

“Yes.”

“Then you are the man I must see.”

“If you’re having problems in one of your classes...” I began.

“I do not take classes,” he said haughtily. “I am a true Maasai.”

“Almost everyone on Kilimanjaro is a true Maasai,” I replied. “That doesn’t mean they have to remain ignorant.”

“I do not seek lectures from you, only answers.”

“I can’t promise to give you the one without the other,” I said, turning back to my computer. “Perhaps you can find what you need elsewhere.”

“You see?” I said with a smile. “Even a Maasai can apologize, and the world doesn’t come to an end.”

“You are a very strange Maasai,” said Mawenzi.

“And you are a very troubled one,” I said. “Would you like to tell me about it?”

He nodded. “My father—my true father—is dead.”

“I’m sorry.”

“It was a long time ago,” he said distractedly. “And my mother has wed again.”

“That is good,” I said.

“That is the problem,” replied Mawenzi.

“You don’t like your new father?”

“He is a good man. He provides for us, he is never too stern, he cares for my two sisters and myself as if we were his own children.”

“Now that he has married your mother, you are his children,” I pointed out.

“He has never beat us,” continued Mawenzi. “We have never gone hungry, our cattle are healthy and fertile, and he is a respected elder.” He paused. “There

can be no doubt of it: he is a good man.”

“I take it that he is also somehow connected with your problem?” I asked. He nodded. “Yes. Even though he is a good man, I must pit you against him, and you must triumph.”

I did a double-take at that. “You’re not seriously suggesting that I fight your new father?”

“No. He would kill you very easily.”

“Then perhaps you’d better tell me exactly what your problem is, and what you expect me to do about it.”

“I am fourteen years old,” said Mawenzi. “Next month I was to be circumcised in the ceremony that will turn me from a boy into a man. My father chooses to live in the old way, herding

his cattle, but he has been to school in Kenya, and he reads books.”

“And he doesn’t want you circumcised?” I said.

“He calls it barbaric, and refuses to allow it.” Suddenly the arrogance was gone, and it was all Mawenzi could do to hold back his tears. “If I am not circumcised with the rest of my age group, I can never take a wife or have my own manyatta. All I ask is not to be different from my peers. I do not wish to move to the city, or learn the secrets of your computers. I do not wish to fly high above the ground in the airplanes that pass overhead. I want only to be a man, and be accorded a man’s rights. Is that so much to ask?”

“No, it isn’t,” I answered.

“You are an historian,” he continued.

“You can speak to my new father, can tell him that this is our tradition, that it has always been done this way. He himself was circumcised as a boy, or he could never have married my mother, or cut off his braids and painted his head with red ocher. Why should he deny me what he himself possesses?”

I couldn’t help but admire young Mawenzi’s intelligence. He knew he needed help to convince his father to let him undergo the ritual, but he also knew that none of the neighboring elders who had to work with his father would be likely to argue with him over this, so he used his brain and came up with the one

person who could best explain the sanctity of Maasai traditions—an historian. But while I admired Mawenzi's intellect I also resented it, because up to this moment I had been a student and a chronicler of life on Kilimanjaro, and now he wanted me to become an active participant. My first thought was that his stepfather would run me through with his spear for having the temerity to interfere in his family's problems. But then I thought of Mawenzi, who would of course grow up to be a man, but would never be convinced that he had reached manhood until he had been circumcised. I was still considering my reaction when Mawenzi spoke up.

“You have been silent for a long time,” he said. “Is something wrong?”

“No,” I said. “I’m thinking.”

“Will explain to my father why I must be circumcised?”

“You came all this way and sought me out in a city that is very strange and frightening to you,” I began.

“It is strange,” he agreed. “But I am a Maasai. Nothing frightens me.”

“Fine,” I said. “You have found me and asked for my help. You will find it hard to believe, but no one has ever asked for my help before, and I was very content with that. But if you’re not afraid to come here, what kind of Maasai would I be if I were afraid to help you?”

He tried to hide his relief, but didn’t

quite manage.

“Tonight you’ll sleep in my apartment,” I said, “and tomorrow we’ll go to your manyatta and see your father.”

He looked underfed—all the pastoralists looked underfed—and I decided he needed a meal. I knew better than to take him to a restaurant, so I took him to my apartment and fixed him a beef sandwich. He stared at it suspiciously—he had never seen sliced bread before—but finally he took a bite, and then another, and he wolfed it down so fast that I made him another, which he ate almost as quickly. I offered him a glass of milk, which he refused because it had no blood in it. Then I made him a dish of ice cream. I had some strawberry

syrup, and I poured some of it onto the ice cream. It looked just enough like blood that he was willing to try it, and I could tell by his face that he might never miss the city but he would miss ice cream every day for the rest of his life.

I brought him to my guest room and showed him the bed, then went to my own room. When I woke up the next morning, I saw that he had pulled the mattress onto the floor and had slept on it that way. Mawenzi had ice cream for breakfast, and then I got my car out of the garage. He had seen cars almost every day, but he had never ridden in one. Before long he was hanging so far out of the window, looking at every passing sight, that I was afraid he might fall out

if I hit a bump. Finally we arrived at his manyatta, a series of mud-and-dung huts clustered together, surrounded by a fence made from the branches of thorn trees. The fence served no purpose—historically all the family's cattle would be enclosed at night to protect them from predators, but there were no predators any longer—but Mawenzi's family, like most of the pastoralists, still honored the tradition. All of Mawenzi's siblings—there were five of them, two by his blood father, three by his adopted father—came up, wide-eyed and curious, to see the car. A minute later a grown man wearing a t-shirt and shorts walked up, and I knew this must be Mawenzi's stepfather.

“Has Mawenzi gotten in trouble?” he asked in English.

“No,” I replied.

“Good. I was worried when I saw your car. Clearly you’re from the city. What was he doing there?”

“He sought me out to ask my advice,” I said carefully. Since we were speaking English, I extended my hand. “I’m David ole Saitoti.”

“I am Samuel,” he replied.

“Just Samuel?”

“Samuel is enough. What particular advice has Mawenzi sought?”

“He needed my expertise as an historian,” I said.

He nodded his head. “I thought as much. Let’s walk and talk. There’s no

need to discuss this in front of my children.”

He began walking off toward his cattle, and I joined him.

“It’s about the circumcision ceremony, isn’t it?” said Samuel.

“Yes, it is,” I answered.

“And he has told you that I’m a cruel, unfeeling man and a false Maasai?”

“No, Samuel,” I said. “He has the utmost respect for you.”

“Really?” he said. “That’s surprising. I know how much this means to him.”

“Then why not let him be circumcised?” I asked.

“I have my reasons.”

“Perhaps you’d care to share them with me,” I suggested.

“You’re an historian,” he replied. “You’ve come here at Mawenzi’s request, to argue his case. You’re going to tell me that this has been the Maasai’s ritual passage to manhood for millennia, and that I’m shaming him by not permitting it.”

“Do you care for him?” I asked.

“I love him as if he were my own blood son,” said Samuel.

“Then why are you denying him his passage to adulthood?”

“It’s a brutal, barbaric custom!” snapped Samuel.

“Yet you yourself were circumcised,” I pointed out.

“Yes, I was.”

“And it did you no harm.”

“None.”

“Then why—?”

He seemed to consider his answer for a long moment. Then he stopped walking and turned to me.

“Mawenzi’s mother is not my first wife,” he said. “My first wife died—but before she died, I had a son. He was very much like Mawenzi: bold, courageous, intelligent. And like Mawenzi, he took great pride in being a Maasai and in honoring our traditions.”

“Including circumcision?” I asked.

“Including circumcision,” said Samuel.

“He should be a young man now,” I said, wondering where this was leading. “Does he live on Kilimanjaro?”

“He’s dead,” said Samuel, and I could see the emotional pain in his face. “He died from an infection caused by the circumcision ceremony. It was on that day that I rid myself of all names except Samuel, I cast aside my red blanket, I began to grow my hair, and I swore that no child of mine would ever be circumcised again.”

“I see,” I said.

“It is a brutal custom,” he continued. “We have hospitals that insist on sterile instruments, on disposable gloves for surgeons and nurses, on antiseptic cleansers for everything within the building. And yet when I was circumcised I stood knee-deep in a polluted stream, and was cut by a knife

that had cut every member of my circumcision group, that still bore their blood. I knew that no Maasai is supposed to show pain, so I stood there like a statue, despite the agony I felt, unaware of the possible effects of the ceremony. I was proud of myself, and years later I was equally proud to have my son undergo the same ritual. When he became ill I took him to the laiboni, and only when the laiboni could not cure him did I take him to the hospital in the city, where they told me they could not save him, that we had waited too long. On that day I discarded my red blanket, threw away my spear, and allowed my hair to grow long again.” A look of fierce defiance spread across his features. “I

will not lose another son to this madness!”

“I see,” I said. The laiboni is the witch doctor.

“Is that so cruel?” he demanded.

“It’s not cruel at all,” I said. “But it can have cruel consequences. Mawenzi will not be allowed to take a wife, or to start his own manyatta.”

“Only if he remains out here,” he said, indicating the savannah with a sweeping gesture. “This won’t hamper him in the city.”

“But he wants to live a traditional life as a pastoralist,” I pointed out, “and this will be denied him.”

“If what happened to my son happens to him, all life will be denied him,”

replied Samuel firmly.

“There must be a compromise,” I said.

“There’s no solution that will please both sides,” said Samuel.

“That’s possible,” I said. “But I promised Mawenzi I would try, and I’m going to keep my word to him.”

He walked off to tend to his cattle, and I remained where I was, analyzing the situation. It did indeed seem insoluble, because each side had a strong moral argument: Samuel did not want Mawenzi endangered, which was reasonable and displayed a father’s love and concern; and Mawenzi wanted his birthright, his passage to adulthood, which was equally reasonable. Slowly it

dawned on me that if the problem were to be considered in that light, it would require an ethicist to solve it, because it was clearly an ethical dilemma.

But I am not an ethicist. I am an historian, and I knew that if I were to find a satisfactory solution, it would be because I used my special knowledge. And when I realized that was the approach I must take, I began to see how the problem could be resolved.

Finally I walked back to Mawenzi's hut. He was there, trying not to appear too hopeful or too surly. I told him to have one of his siblings go out into the fields and bring Samuel back to the hut. When he arrived, I had both of them sit on their low three-legged stools, while I

stood across the hut, facing them.

“You have asked for my help,” I said to Mawenzi. “And you,” I said to Samuel, “haven’t denied me the right to try to help.”

“That’s true,” said Samuel.

“I’m an historian,” I continued, “so it is to history that I look for guidance. Now, there is almost no Maasai history before the 18th century a.d., some five centuries ago—but that doesn’t mean that all history began then. The Chinese and Egyptians have histories that go back thousands of years, and more to the point, so do the Jews. And the Jews were circumcising their male children millennia before there was a Maasai tribe.”

“Do they still?” asked Mawenzi.

“They do,” I said. “But they don’t do it in streams or rivers, and they don’t do it with unsterilized instruments. In almost every case they do it in hospitals under conditions that guarantee no one will ever suffer or become ill from the process. Many Christians are also circumcised in hospitals.”

I turned to Samuel. “If Mawenzi is circumcised in the hospital, will you have any objection?”

“No,” he said.

“Mawenzi,” I said, “if you are circumcised alone, not by a laiboni but by a doctor, will this satisfy you?”

“Can’t the doctor come and circumcise all of us in the traditional

way?” he asked. I shook my head. “No doctor will agree to that, because it could cause infection and disease.”

Mawenzi seemed lost in thought for a moment. Then he looked up. “I will agree to it, as long as it is known in the manyattas that I have been circumcised.”

“It will be,” promised Samuel.

The next morning Mawenzi became the first Maasai to be circumcised under sterile conditions by a medical doctor.

And then something strange happened. Suddenly most of the young men asked to be circumcised in the same way, for they could see no reason for suffering pain if they didn't have to. They were proud young men, and none would have volunteered to be the first, but once

Mawenzi did it, they had no problem following suit.

It was when some of the girls asked to be circumcised in the hospital that the doctors categorically refused, claiming that it served no medical purpose and was a cruel and unnatural surgery that was in fact against Nature's intentions. The girls are still circumcised in the old way—but a few have refused, and I think next year even more will refuse. We can't win every battle, but if we persist, eventually we can win the war.

All that happened three months ago. There has yet to be a sign of infection, all because of one boy who insisted on honoring a tradition that his father opposed, and one historian who found

the solution not among the Maasai but rather with a much older tribe.

Noon on Kilimanjaro (2237 a.d.)

I had just come back from a drive through the game park, which I always find relaxing. For centuries the Maasai had lived in harmony with the land, had shared that land with the creatures of the African wilderness, and then one day, seemingly overnight, there were no such creatures left. The great cats, the pachyderms, all the herbivores and carnivores, were gone. Poaching had reduced their numbers, of course, but it was habitat destruction that was the true cause of their extinction. Animals can come back from poaching, or from

disease, or from drought—but once humanity has taken over their habitat, there is no place for them to come back to. So it was very pleasant, especially for an historian who knew the way we used to live, to be able to sit in my car by a water hole, watching the impalas and zebras and elands and buffalo come down to drink.

When I returned to my office, I found my friend Joshua ole Saibull, the lawyer, pacing restlessly back and forth in the foyer of the building.

“Hello, David,” he said in English when he saw me. “Where the hell were you?”

“At the game park,” I replied.

“Again?” he said with an amused

laugh. “Are you an historian or a naturalist?”

“I’m just a person who finds it relaxing to watch wildlife,” I said. “I assume you’re here to see me?”

“Well, come into my office and tell me what I can do for you.”

“Who is William Blumlein?” I asked as he sat down on the same chair that Mawenzi had refused a year ago.

“You’re spending too much of your time dwelling in the past,” said Joshua.

“That’s my job.”

“This is a man that historians will be studying and praising a century from now.”

“Enlighten me,” I said, finally sitting down behind my desk.

“William Blumlein is one of the leading sociologists on Earth,” said Joshua.

“William Blumlein,” I repeated. “Is he white?”

“Yes,” he said.

“I assumed as much from his name,” I said. “Well, tell me about him.”

“He wants to live here,” said Joshua. “He’s spent the past decade studying the

Maasai in Kenya and Tanzania, and now he wants to immigrate to Kilimanjaro and spend the rest of his life right here, researching us.”

“Why?” I asked.

“Why do you study our history?” shot back Joshua. “He’s fascinated by the Maasai. The only difference is that you’re concerned with our past and he’s interested in our present and future.” He paused. “Trust me, David—this man can do important things for us.”

“All right,” I said. “I have no reason to doubt you. What’s the problem?”

“What did you think it is?” he said irritably. “Those hidebound fools on the Council of Elders don’t want him to come here.”

“I thought they weren’t invoking the fifty percent rule until we were fully populated,” I said. “We can still handle another seven or eight thousand immigrants, possibly even a few more.”

“They’re opposed to him because he has no Maasai blood at all.”

“This doesn’t make sense,” I said, shaking my head. “I know for a fact that they accepted a family of Zulus last month, and they certainly had no Maasai blood. And two Mtabele immigrated here the month before that, and—”

“Damn it, David!” snapped Joshua. “Open your eyes! It isn’t his blood. It’s his color!”

“There is nothing in our charter that says whites can’t immigrate to

Kilimanjaro,” I said.

“There is nothing in our charter that says the Council of Elders has to behave like reasonable human beings and accept him either,” said Joshua. “But if they don’t, it won’t take long before there’s a backlash. Not only will no whites want to live here, but those who service our master computers, who help us clone our animals, who export the materials we need to expand our cities, will refuse to come here to a world of bigots. This could drive all white investment away.”

“It’s possible,” I agreed.

“I’ll be representing him before the Council,” said Joshua. “I’d like your help.”

“Freely given,” I told him. “I don’t

give a damn about white backlashes or future economic investment. I'm only concerned with the morality of the situation, and if we are to be a Utopia, then it's clearly immoral to refuse this man the right to come here solely because of his color."

"Good. I knew I could count on you."

"Just be glad that I'm the only historian on Kilimanjaro," I said. "Because any historian could make the argument that this is merely a case of payback. The whites discriminated against the blacks for centuries, even buying and selling us as slaves at one point."

"That was all hundreds of years ago," he said impatiently.

“My job is to study what happened hundreds of years ago,” I replied.

“I’m more concerned with what will happen next week,” said Joshua. “This is a brilliant man, a decent man, who wants only to live out his remaining years here studying us and codifying what he learns for future generations—including future generations of Maasai. “No one becomes a Maasai,” she said harshly. “You are born one or you are not. It’s as simple as that.”

“Yes, I suppose so,” I said. “After all, it’s not as if he’d been carried off in a raid and forced to wed a Maasai.”

She stopped and stared at me, and I could see that the notion had registered.

“It was a silly suggestion,” I said. “Such raids ended centuries ago, and besides, he’s not a woman to be made

one of a warrior's wives.”

She seemed lost in thought and again made no reply, and I walked over to where Joshua and Blumlein were waiting in the car.

“What was that all about?” asked Joshua.

“I momentarily became a farmer,” I responded.

“What are you talking about?”

“I planted a seed in the most fertile ground on Kilimanjaro,” I said. “Tomorrow morning we will see if it has sprouted roots and grown.”

“I understand laibonis, who deal only with the supernatural,” complained Joshua. “Why is it that historians and sociologists speak in riddles?”

“Who would pay for a rhino horn?”

“What was a rhinoceros horn worth in Kenya shillings?”

Insufficient data. Since the value of both the horn and the shilling fluctuated, I must be given a time frame.

“All right. What was the value in 1980?”

From 22,000 to 30,000 Kenya shillings, depending upon the size and quality of the horn.

“And the shilling was worth how much?”

The rate of exchange in 1980 was 4.23 Kenya shillings to the British pound.

“What was the per capita income of the Kenyan citizen, regardless of tribe, in 1980?”

2,491.28 shillings per annum.

I was silent for a moment while I did

the math in my head. No wonder they had killed almost a million rhinos! A dead rhino was worth an average of more than ten times what most Kenyans could earn in a year!

“Computer,” I said at last, “is there a market for rhino horns today?”

The market is extremely limited because the horns are almost unattainable, but such rarities would clearly fetch prices well in excess of those that were obtained during the late 20th and early 21st centuries. Adjusting for inflation, a minimum price would be 625,000 shillings, probably far more if interested parties were allowed to bid against each other.

I contacted Joshua on the vidphone

and told him what I had learned. He seemed unimpressed.

“I knew most of that, and surmised the rest,” he said. “That’s very disappointing news, David.”

If we don't put a stop to this right now, the poacher will strike again. After all, it's easy money, and it's huge money. And when word gets out, and it always does, we'll have more poachers.”

“Could Moses have done it?”

“Not a chance,” answered Joshua. “They found him on this side of the force field. Hell, Moses couldn't cross that field without killing himself on those rare occasions that he's sober. He

certainly couldn't have done it tonight. As for shooting a dart accurately in the dark..."

"All right," I said. "Then it's an easy case and you'll get him off."

"I'm not concerned with case, damn it!" he half-yelled. "I'm concerned with catching the poacher and making sure it doesn't happen again so our game parks aren't overrun by them!"

He broke the transmission.

I thought of going back to bed, but now I was awake and alert, and it occurred to me that my job wasn't done yet. I knew how rhinos had been poached to the brink of extinction in the late 20th century—but the fact was that they had survived another fifty years.

How?

“Computer?” I said.

Activated.

“What was the rhinoceros population of Kenya in 1950?”

103,625 black and 17 white.

“In 1990?”

Well, it was obvious when most of the poaching had been done.

“In 2010?”

1,238 black and 28 white.

So the black rhino, which seemed headed for immediate extinction in 1990, had tripled its number in the next twenty years. I asked the computer to explain

“No reason why you should,” he replied. “You're neither a policeman nor a politician.”

“You haven't been paying attention to your own arguments,” said Blumlein with a laugh. “Whoever he is, we'll reach an accommodation with him, and because of his skills he'll become the leader of our anti-poaching team. Just because we capture him doesn't mean

collectors will stop offering huge prices for trophies, and that kind of offer always gets a response.”

And sure enough, three days later we caught the poacher when he tried to put the money in a safe box under the watchful eye of the bank's security holo camera.
